All entry applications will be reviewed by the CDGA to verify that the entrants have an official USGA/GHIN handicap index.

ENTRY DEADLINE: All entrants must file an application by the entry deadline – **Friday**, **July 15** to be eligible to compete in the Tournament.

Late or incomplete applications are not accepted.

misdirected mail.

CONDUCT CODE: Penalties for breach of sportsmanship code (to include, but not limited to property damage, abusive language, club throwing, excessive drinking or gambling) may include censure, suspension or revocation of playing privileges. USGA Decisions on the Rules of Golf.

CDGA DRESS CODE: Contestants must wear appropriate attire. Gym shorts, cut offs, shirts without collars, and denim shorts or pants are not acceptable. Shorts must be Bermuda length in type.

REFUNDS: No refund will be issued after the deadline except for illness/injury.

FOOTWEAR: Traditional type spikes, regardless of composition, are prohibited at the Tournament. Penalty for breach of this condition of play is disqualification.

PRIZES: Trophies for champion and runner-up team members, **traveling trophy** to be displayed at CDGA member club represented by the champions.

1st and 2nd ROUND MATCHES: First and second round matches will be scheduled by opponents at a mutually agreed upon time.

Location will be chosen from clubs listed to left by top seeded team. Choosing team may not select the club it represents.

First round matches must be completed by end of day Thursday, August 3.

Second round matches must be completed by end of day Thursday, August 17.
